## **Joint Local Plan Update**

The joint Local Plan achieved a major milestone in the production of our districts' Joint Local Plan (JLP) – our blueprint for the future development of Babergh and Mid Suffolk up to 2037.

It sets out a vision for the districts, including policies to address social, economic and environmental issues, resulting in a framework to guide future planning decisions. It is a massive undertaking, designed to help shape our districts in terms of providing sufficient housing, employment and inward investment, protecting our environment and heritage, and ensuring we have the infrastructure in place for healthy communities and thriving towns.

Crucially, the process also requires consultation with our local communities, with our JLP incorporating feedback and thousands of responses over several years of development.

Before a Local Plan can be adopted it goes through an independent, rigorous and lengthy examination process by the Planning Inspectorate. This week the Planning Inspectors published their report confirming that – subject to some modifications – our JLP can be considered sound and capable of adoption.

This means greater certainty and clarity for communities, businesses, and developers – with our JLP now expected to go to Babergh and Mid Suffolk's Full Council meetings in November for formal adoption.

This process has not been without its challenges and, although Local Plans rarely go through without some modification, ours saw a fundamental change back in 2021 when we agreed with the Inspectors that we should progress the JLP in two parts, with housing allocations addressed in Part 2.

The Part 1 plan sets out policies that support the delivery of housing, including affordable and supported and special needs housing, safeguarding employment and community use, policies that enhance and protect the environment, and development standards on environmental performance, design and sustainability.

Within their report, the Inspectors have recognised that this part of our plan contains appropriate policies to help mitigate and adapt to climate change in accordance with national policy, and allocates more employment land than necessary, providing enough flexibility for us to respond to changes in market conditions.

The Inspectors are also satisfied that we have sufficiently met our housing need for the districts while we now continue to work on Part 2 – helping us to restrict any unsuitable speculative development in the meantime.

It supports the councils' and the Suffolk Climate Change Partnership's net zero ambitions by helping and encouraging communities and individuals to live more sustainably.

## Help to tackle loneliness for older residents

The councils are once again lending their support to the Silver Sunday campaign, designed to help tackle the issue of social isolation, particularly for older residents in rural communities. Silver Sunday first took place in London in 2012, but is now recognised nationally, with hundreds of events now taking place across the country – including five in Babergh and Mid Suffolk.

Local events will see students from Thomas Gainsborough School join members of the Sporting Memories group for games at the Kingfisher Leisure Centre, plus a rock n roll themed party hosted by the Ansell Memories Café at the Ansell Centre in Hadleigh.

Young people from Eye Local Opportunities group will be joining residents at Hertismere Place Care Home for an intergenerational sing-along and stories, with a similar event at Finborough Court Care Home for local schoolchildren later in the month.

The final event of the month is being hosted by Needham Market Football Club and involves Needham Market Sporting Memories group and Stowmarket and District Dementia Community Group, with mixed age matches featuring grandparents and younger family members.
